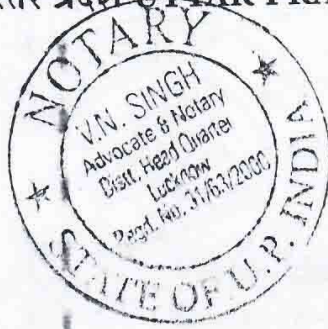

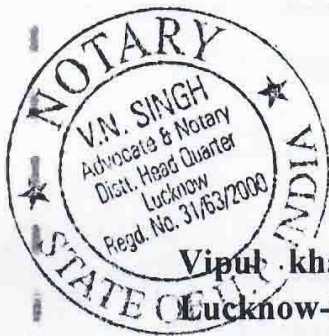

WHEREAS BOTH PARTIES IN THEIR MUTUAL BENEFIT AND INTEREST AGREE AS FOLLOWS :-

1) **Objective of the Agreement :-**

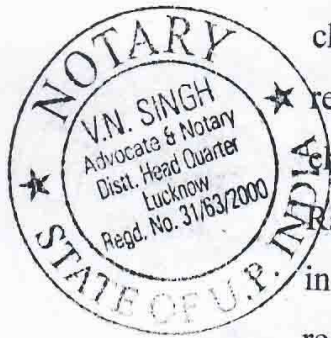
1.1 Objective of the agreement is to conduct Makeup & Beauty Classes for the interested students of Navyug Kanya Mahavidyalaya (the second party) under the Official collaboration with **Aloevera Treatment & Beauty Care (the first party)**.

2.1 **Obligations of Aloevera Treatment & Beauty Care.**

2.1.1 To provide proper :- Makeup & Beauty Training to the newly enrolled cum admitted students at **NAVYUG KANYA MAHAVIDYALAYA** premises of the (E.E. beginners' course) by the **first party**.

2.1.2 To initially enroll Rs. 400 I.N.R. (from fee) shall be charged in cash by per student & later on as the remaining fee of the (beginners' course fee) shall be charged by the first party which amounts to total Rs.2000/- (Two thousands only). Flexibility of payment in installment is also permissible. In case, the students require any sort of Study Material (S.M.) chargeable & solely owned by the first party.

2.1.3 All the above activities will imply on Financial Terms as mutually agreed upon by both the parties. **The fee collection** for the same is solely the responsibility of **the first party**, surely keeping up the transparency of all the new admissions' fee collection obtained by the first party to the second party on a daily or weekly basis. class attendance record of the first party can be checked as and when by the H.O.D.

2.1.4 To provide classes :- 6th days a week (Monday till Saturday), one lecture period to the first party students in the room allotted in their college premises by the second party, also keeping up students convenience.

2.1.5 To provide a proper course duration of :- 4 months once the course begins. The students are even entitled for a certificate on a proper completion of course, with only full fee payment & at least 75% attendance.

2.1.6 To provide the aforementioned classes in the college premises as per batch of 25 to 30, all newly admitted students enrolled by the first party, in their free college period. In case of any disassociation by the either party, at any point of time, the second party shall permit to complete at least the running 'batch of first party's pre admitted students in the second party premises peacefully.

2.1.7 Sharing of revenue by the first party to the second party as mutually agreed upon is:- (20% of 2000/- I.N.R) which comes to:-400/- I.N.R. out of per student beginners' course fee i.e. 2000/- I.N.R charged by the first party, thereby in reference to 2.1.4.

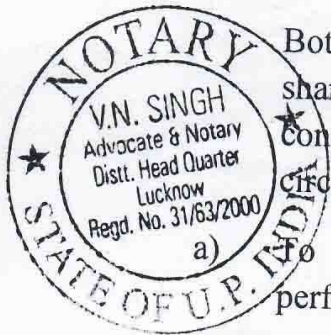
1.8 Payable criteria is 50% of the initial agreed upon amount which comes to 200/-INR (Rupees shall be paid by the first party to the second party in the first week of the following batch starting month ,once the initial fee is

collected from the newly admitted students of the first party except the Drop -outs.

- 2.1.9 The due remaining amount of 50% i.e. Rs.200/- INR shall be done to the second party by the first party in the next upcoming month...even if the first party has not been able to recover the pending installment from the students (i.e but provided that the student is not a (DROP OUT CASE) with the maximum fee pending towards the first party . Verifications of any kind readily accepted by the first party.
- 2.2 The second party shall be paid the above agreed upon amount i.e. Rs.400/- I.N.R per student by the first party through "DEMAND DRAFT"/"PAY ORDER/CASH" in the favour of :- NAVYUG KANYA MAHAVIDYALAYA, LUCKNOW. '

- c) Not to disclose the same to third party.
- d) No alteration or amendment to this MOU shall be effective unless it is in writing and signed by the Parties

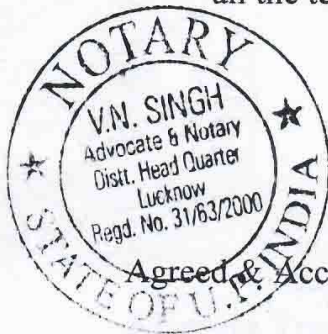
Neither of the parties shall present itself as the representative or agent of the other party, nor shall it have the power or the authority to commit on behalf of
