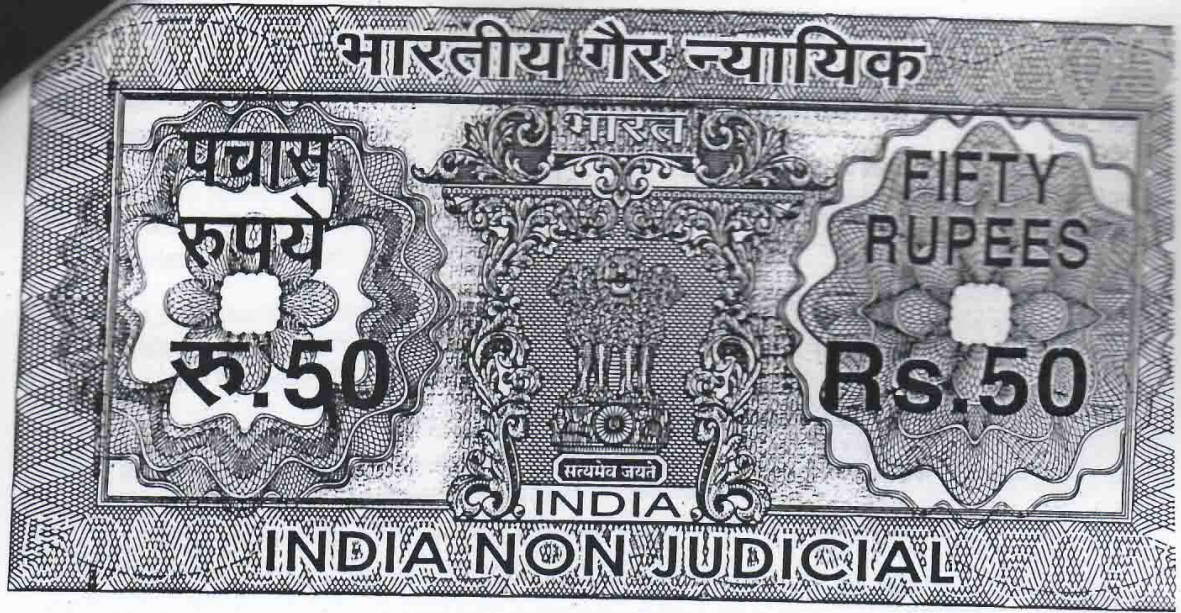

1) Objective of the Agreement:-

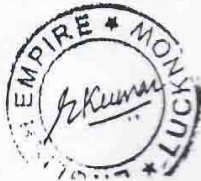
1.1 Objective of the agreement is to conduct Spoken English & P.D.P training programme for the interested students of Navyug Kanya Mahavidyalaya (the second party) under the Official collaboration with English Empire....the ultimate language rulers!! (the first party).

2.1 Obligations of "English Empire"(the first party)

2.1.1 To provide proper :- Spoken English & Personality Development classes to the newly enrolled cum admitted students at Navyug Kanya Mahavidyalaya premises of the (E.E beginners' course) by the first party.

2.1.2 To initially enrol. :-500 I.N.R( form fee) shall be charged in cash by per student & later on 2,000 I.N.R as the remaining fee of the (beginners' course fee) shall be charged by the first party which amounts to total :-2,500I.N.R (Rupees TWO THOUSAND FIVE HUNDRED ONLY ).Flexibility of payment in installment is also permissible. In case, the Students require any sort of Study Material (S.M) like worksheets & C.D's Software then it's extra chargeable & solely owned by the first party.

2.1.3 All the above activities will imply on Financial Terms as mutually agreed upon by both the parties. The fee collection for the same is solely the responsibility of the first party, surely keeping up the transparency of all the new admissions' fee collection obtained by the first party to the



second party on a daily or weekly basis. The class attendance record of the first party can be checked as and when by the H.O.D of the English department.

2.1.4 To provide classes :- 5 days a week (Monday till Friday), one lecture period to the first party students in the room allotted in their college premises by the second party, also keeping up students' convenience.

2.1.5 To provide a proper course duration of :- 3 months 15 days, once the course begins. The students are even entitled for a certificate on a proper completion of a course, with only full fee payment & at least 75% attendance.

2.1.6 To provide the aforementioned classes in the college premises as per batch of 25 to 30, all newly admitted students enrolled by the first party, in their free college period. In case of any disassociation by the either party, at any point of time, the second party shall permit to complete at least the running batch of first party's pre admitted students in the second party premises peacefully.

2.1.7:- Sharing of revenue by the first party to the second party as mutually agreed upon is:- (20% of 2,500 I.N.R) which comes to:--500 I.N.R out of per student beginners' course fee i.e. 2,500 I.N.R charged by the first party, thereby in reference to 2.1.4

2.1.8:- Payable criteria is 50% of the initial agreed upon amount which comes to 250 INR (Rupees Two Hundred & Fifty only), shall be paid by the first party to the second party in the first week of the following batch starting month, once the initial fee is collected from the newly admitted students of the first party except the Drop-outs.
