## WHEREAS

The Second Party shall be implementing an Employability Development Programme (the "Programme"), by delivering Structured Training Modules (Bootcamps) to the students in batches, on the campus of the First Party.

## 1. COMMENCEMENT, COMPLETION, MODIFICATION AND TERMINATION OF THIS MOU

- 1.1 This MOU shall come into force from the date of signing, or other earlier date that is mutually agreed by the two parties.
- 1.2 Modification of the terms and conditions of this MOU may only be made through mutual agreement between the parties.
- 1.3 The MOU shall be valid for one year from the date of signing. The results and outcomes of the Programme are subject to review every year by either party. The terms of the MOU may be A peviewed/modified after the Annual Programme Review.
- 1.4 The MOU may be mutually terminated at any time, if the Programme fails to produce desired Suresh K gresults and outcomes, and/or if either party fails to perform its role or meet its obligations as a decired mentioned in the MoU (below):

2. ROLE & OBLIGATION OF THE SECOND PARTY IN SUPPORT OF PROGRAMME

- F 211 The Trainings offered under the Programme within the premises of the College shall be delivered exclusively to the students of the College.
  - 2.2 The Second Party shall provide services, as per the specifics under each Programme Plan.
  - 2.3 The Training (Bootcamps) shall be delivered by personnel appointed by Medha during the course of the Programme.
  - 2.4 The Programme shall not be offered free of cost. The Programme shall be chargeable on per student basis as per the specific Programme Plan. The Programme fee shall be highlighted in the specific Programme Plan.
  - 2.5 Medha shall reimburse the College, 10% of the total fee collected from the students, to cover the associated overhead costs of the College.
  - 2.6 The Training (Bootcamps) shall be delivered in batches of 25-30 students. The students shall be registered within the Programme in order to form training batches of minimum 25 students in each batch.
